Alberta WUI Program



Background

- Wildland urban interface (WUI) in the past was more of a sprinkler program in AB Wildfire
- Training and development of municipal fire personnel has been haphazard – Boss, Leader, Supervisor, Director/STPS
- AB Wildfire not comfortable with inconsistent standard of training for 1051
- No consistent operating construct for employment of wildland fire, sprinkler operations, and engine operations in WUI

Background

- 2019 OFC / AFCA grant to develop WUI program 18 months
- 2021 WMB / AFCA grant to develop WUI program 12 months
- 2022 AEMA / WMB 3-year CGA to Town of High Level and Clearwater County to develop WUI program
- AEMA and WMB co-manage the AB WUI Program
- Commence build of comprehensive training and development program

Vision

 The seamless integration of municipal fire and wildland fire, supported by industry capability, in the conduct of preparedness and response operations, in the wildland and wildland urban interface environments



End State

A comprehensive developmental system for structural firefighters to ensure safe operations in the wildland and WUI environments, encompassing individual certification at various developmental levels. WUI will become a standardized, recognized, and common skillset amongst Alberta's municipal fire departments

Common Operating Concept

 WUI personnel, primarily municipal structural fire fighters, employing wildland fire techniques, sprinkler operations, and engine operations as part of an integrated response to WUI incidents

- Preparedness role prep for hazard season FD visits
- Field support to STPS and impacted muni fire departments
 - Incident ordering, status/check in recorder, specialist support, demob
- PECC sourcing, ordering, tracking, dispatch
- PECC provincial WUI situational awareness
 - Equipment, status, locations, rotations, link to incident, AWCC





Provincial WUI Teams


- Town of High Level and Clearwater County
- Curriculum development
- Primary WUI trainers
- Provincial response resource
- Most highly skilled and experienced WUI practitioners in AB
- Significant leadership resource on incident
- Continually deployed on incident throughout 2023
- Direct and indirect value well outweighs Provincial investment





Post-Season After-Action Review


- Conducted Nov 9, 2023

- WMB Edmonton, HTC and 10 x Forest Areas
- Provincial WUI Teams
- Senior STPS
- Informed by written submissions from receiving and employed fire departments





Common Doctrine

- Owned by AEMA and WMB
- Delineates structures and options for WUI integration between Alberta Wildfire and Alberta's municipal and Settlement local authorities
- Unified Command Best Practices: WUI
 - To be re-written as "Coordinated Response Best Practices: WUI" this winter
- Annex in AIMS and attached to WUI Guidelines
- WUI doctrine is part of an AB EM system
 - ICS compliant
 - Component of AIMS
 - Supported by AHIMT and Wildfire IMT
 - Reflects AB perspective on Municipal EM structures

Wildfire Season 2023


- Worst Alberta wildfire season on record
- Most communities under WUI threat ever
- PECC WUI responding to resource requests 29 Apr 02 Oct
- First deployment of Provincial WUI Staging Areas
 - Cut 20 to 30 hours off deployment timelines as majority southern departments
- Canadian Armed Forces deployment of 6 x T6 Engines to Fort Chip
- PECC WUI moved more apparatus and personnel than previous decade combined
 - Estimate 430 apparatus and 2500 personnel movements
- Program, doctrine, and operating concept all validated
- Other jurisdictions showing interest in AB WUI Program

WUI 2024 proposed changes

 Augmentation program developed, WUI FOs deploying more to incidents to support local authorities and STPS

 Proposal that Forest Areas pick up WUI invoicing from local authorities if in proper unified command or coordinated response
